Additional Info to Consider

In the case of non-clinical academic staff (who may be working predominately in research), opportunities for clinical teaching are in many cases likely to have been very limited. Many non-clinical staff within the School of Medicine will have been employed specifically to undertake research, with little, or no, expectation that they should take part in undergraduate or postgraduate teaching.

Other non-clinical academic staff will have been employed to work predominately in learning and teaching with limited opportunities to undertake

research.

The Promotions Panel will balance the need to recommend promotion according to the published University criteria against these special factors that make assessment against the standard yardstick difficult.

The panel will take into account part time working and career breaks for all candidates.
